FIRES

SMALL FIRE (trash can size) – If you have been trained, you may put out the fire using a fire extinguisher. Report the fire. Dial by calling 911. Notify EH&S at 212-998-1450 anytime a fire extinguisher is used or discharged.

LARGE FIRE (requiring more than 1 fire extinguisher) – Evacuate the area. Close all doors and windows as you leave. Close the fume hood sash if the fire is in the fume hood. Activate the nearest alarm. Call 911 (x8-2222 or 212 998-2222 from cell phone). Evacuate the area using the stairwells. Do not use the elevator.

CLOTHES ON FIRE – Use nearest safety shower. If none immediately available, STOP-DROP-ROLL to quickly smother the fire. Seek medical attention. Notify supervisors and EH&S at 212-998-1450 and public safety 212 998-2222 immediately.

CHEMICAL SPILLS

The range and quantity of hazardous substances used in laboratories requires preplanning to respond safely to chemical spills. The cleanup of a chemical spill should only be done by knowledgeable and experienced personnel. Spill kits, absorbents, reactants and protective equipment should be available to clean up minor spills. A minor chemical spill is one that the laboratory staff is capable of handling safely without the assistance of safety or emergency personnel. All other chemical spills are considered major chemical spills. Click [here](#) for more information on chemical spills.
